I understand that I am signing a 12 month commitment for membership. After the 12 months, I will be a member from month to month. I understand that first month dues must accompany this application. I understand that my accepted application constitutes a binding agreement with the club and I will be subject to all policies, procedures and rules set forth in the club by-laws, membership manual or by the Board of Directors and General Manager. Failure to abide by any policy, procedure or rule may constitute disciplinary actions up to permanent suspension. I understand that in order to resign, I must provide a written 30 day notice after which I will be billed only for charges to my account during those 30 days including incidental charges including but not limited to rental fees, merchandise, food, beverages, gratuity and all applicable sales tax. I understand I will receive a monthly statement the first week of each month and payment is expected by the 12th. I understand that my credit card will be charged the full balance due on the 15th of that month if I payment has not been received. If I would like to dispute any charges on my statement I must do so before the last day of current billing month. If for any reason my balance is unable to be processed to the credit card I have on file I will be charged a \$25 late fee. If my account becomes 60 days past due, I will be notified in writing that my charging privileges have been suspended and my balance is due. If the past due amount is not paid in full by the third billing date my membership will be terminated and the Club will take legal action if no payment arrangements have been made. If a member drops their membership they are not eligible to join again for 12 months.

The Club at Ironwood reserves the right to establish and amend its policies and procedures governing the operations of the facilities. Every effort will be made to inform members of changes to the policies and procedures in a timely manner.

MEMBERSHIP RULES AND RESPONSIBILITIES

Each member agrees to abide by all policies and procedures established by The Club relating to proper conduct and facility usage. Membership privileges may be revoked and the rights of any persons entitled to privileges under that membership for any but not limited to the following reasons:

- Delinquency of payment
- Destruction of club property
- Physical or Verbal abuse of members, staff or guests
- Continued and repeated violations of Ironwood policies and procedures

The Ironwood Board of Directors has the absolute right and authority to restrict or suspend for a definite or indefinite amount of time the membership privileges of any member found to have violated any policy or procedure established by Ironwood.

Children under the age of 16 are welcome in Ironwood facilities when accompanied by an adult unless management has granted for an unaccompanied visit.

Members must check in with the golf shop staff prior to proceeding to the course. Ironwood is not responsible for damage to the golf cart, course or any injuries sustained by the driver, passengers or other golfers due to recklessness. A golf cart driver must be 16 years of age.

No alcohol may be brought onto Ironwood premises for consumption. No underage drinking is permitted. All alcoholic beverages must be purchased at designated Ironwood facilities and consumed within ABC permitted areas. Ironwood reserves the right to expel any member or guest who violates ABC policies as set forth by the state of Virginia.
